Dear Friends,

If there is one defining cultural trait at the Forsyth Humane Society (FHS), it's that we are always looking forward. In January 2018, FHS embarked on a partnership with Forsyth County Animal Services to manage both the county shelter on Sturmer Park Circle and our existing facility on County Club Road. The dramatic rise in the number of animals we are now accountable for required immense planning and a thorough evaluation of our existing programs. We enthusiastically embraced this undertaking with an overarching goal of reducing the homeless animal euthanasia rate in our county to less than 10%, effectively defining Forsyth County as a "no-kill community."

In 2018, our strides towards this goal have been significant. At the beginning of our partnership, the number of dogs and cats in our county that were adopted, transferred to outside rescue organizations or returned to their owners was 36%. At the end of 2018, that number is 71%. This has only been achieved through the tireless work of our dedicated team of staff, volunteers, foster families and our community.

There were, of course, many memorable and amazing pets saved over the past year. For me, the most special dog was a heartworm-positive Great Pyrenees, found in a ravine with her 6-month old pup. This gorgeous dog is now part of my family where she spends her days guarding the backyard from squirrels and serving as my six-year-old's "police dog" as she patrols the neighborhood looking for villains. We named her Lady Francis Bacon, and she lives up to the quality of statesmanship you would expect from a name like that.

Just as Lady Francis Bacon has impacted my family's life, FHS will continue to touch the lives of people in our community in unique and special ways not only as we care for the homeless dogs and cats in Forsyth County, in pursuit of further reducing the euthanasia rate, but in looking towards the future and how we can make a more positive impact on the pets in our community.

Community Impact #SAVEFURSYTH

Last year, we announced our goal to increase the save rate of shelter dogs and cats to 90% by 2023. On January 8, 2018, Forsyth Humane Society (FHS) became a contracted partner of Forsyth County. FHS assumed all care for dogs and cats at the open admission animal shelter. In 2018, we increased the save rate of shelter dogs and cats from 36% to 71%.

During our partnership, new programs blossomed to help us reach our 90% goal. We increased our placement program to include out of state transport and release to rescues. Dogs and cats in our care went to rescues who found them loving forever homes. This expansion allowed us to make room for more incoming dogs and cats.

Our partnership with Forsyth County included taking in stray dogs and cats from the community. Dogs and cats who entered our shelter as strays are checked for a microchip to help us reunite them with their owners. Our team checks lost and found websites as well. In 2018, we **reunited 725 lost** dogs and cats with their owners.

In February, we asked **over 100 local businesses** to become #SAVEFURSYTH partners. They committed to the 90% goal and helped us increase awareness in Forsyth County. #SAVEFURSYTH partners spread awareness about our life changing mission on social media, pass out informational cards and host awareness events.

FHS strives to keep companion animals in the homes of the underserved population of Forsyth County. We supply dog and cat food to local pet food pantries and Senior Services Meals on Wheels. In 2018, FHS **donated 26,000 pounds of food** to community pantries. We also assist our community by offering low-cost spay and neuter surgeries to Forsyth County residents who are financially challenged. Unwanted litters are financially stressful for our community and prevention is essential to reaching our save rate goal. In 2018, we **spayed or neutered over 300** dogs and cats for the public at a reduced cost.








As of the end of 2018 we have succeeded in increasing the save rate of shelter cats and dogs in Forsyth County from 36% to 71%.
