#### **Position Summary:**

Perform daily care and sanitation of the animals and facility according to FHS policies and procedures. Maintain cleanliness of animal housing areas, and public areas of the building. Assure all animals are cared for with appropriate food, water, daily exercise and living conditions. Monitor the health and wellbeing of the animals, and report daily to the Health & Wellness team. Prepare kennels for new animal intakes. Comply with Department of Agriculture sanitation regulations.

- 1. Maintain clean and sanitized housing for all animals
- 2. Maintain group rooms and play areas
- 3. Maintain feeding stations, including washing dishes
- 4. Complete daily feeding according to FHS protocol
- 5. Maintain cleanliness and sanitation of all public areas of the building, inside and outside
- 6. Refill food bins as needed
- 7. Do daily laundry
- 8. Prepare spray bottles, mops, and trash cans for volunteers
- 9. Keep storage areas organized and cleaned
- 10. Keep an eye on inventory needed for animal food and litter and inform supervisor when low
- 11. Ensure practices meet Department of Agriculture guidelines for sanitation
- 12. Have a working knowledge of the Animal Welfare Act, section NCAC 52J.0204-0207
- 13. Provide excellent customer service when dealing with the public
- 14. Report daily accurate animal health, wellbeing, and emotional needs to the Health & Wellness team
- 15. Provide facility maintenance requests to supervisor as needed
- 16. Process donations as needed
- 17. Complete daily enrichment for all animals in care
- 18. Other functions as determined by Leadership
